- 4.2 Senior Center update- Rosa Chappell/JGF
 - Highlights: March & April over 581 patrons attended health & fitness classes
 - 1457 participants signed up for nutrition-based programming
 - Community Action Partnership and their volunteers coordinated 84 tax preparation appts.
 - Mead Valley Senior Center with Family Resource Center hosted a Dia del Nino celebration in which 30 seniors and 64 children attended.
 - Encouraged everyone to pickup a monthly calendar for a schedule of upcoming events and programs.
- 4.3 Mead Valley Library- Karen Snider
 - Library had a total of 5082 patrons for the month of March and 5046 for April
 - Library hosted 35 programs in which 482 people attended
 - Dia de los ninos event turned out 209 people
 - Upcoming events: Summer reading sign ups begin June 5th, Kickoff party beings at 1pm

- 4.4 Newcastle Partners Amanda Tropiano [New proposed Logistics Center, Val Verde]
 - Proposed 270,000 square foot warehouse on Harvill & Morgan St.
 - 13 acres, light industrial storage, cold storage
 - Will create approximately 250 construction jobs and 100 to 150 permanent jobs for the community.
 - Project is still in the review phase and Developer looking for community feedback.

- 4.5 Newcastle Partners Amanda Tropiano [New proposed logistic center, Harvill]
 - Proposed 320 340,000 square foot warehouse
 - Located on 17 acres at Harvill & Orange by Salvation Army
 - Project will create 300 construction jobs and opportunities and 200 to 400 permanent jobs for the community which will help alleviate traffic on the I 215 & 60 corridor by keeping jobs in the community.
 - These projects are designed to protect the line of sight view for the local residents of the community. They will bring much needed Industry to the local economy while maintaining a certain level of aesthetic appeal which Newcastle takes pride in.

5.0 Public Comments

- John Byrns: Update on Orange Rd.? Who is the individual responsible for future improvements to the Valley? What is being done about the flooding issue? Is someone looking for funds for the issue? Need to seek remedies for congestion and poor infrastructure.
- Joshua Naggar: Has issues with the length of time a resident has to tolerate construction. Wonders is anything can be done by the county to speed up construction to alleviate the burden on the homeowner. Has issues with the current industrial buildings emitting too much light. Can someone address the issue of light pollution?

- Jerry Avila: The Board, The Sheriff, the residents of the community need more authority in the valley they reside or patrol in. Sheriff need a satellite office in the Valley. Ben Clark range is driving him crazy.
- Maricela Martinez: Gives thanks the developers for bringing growth and jobs to the community.
- Gloria Hernandez: Owner of a property on Brown and Orange installed a 6' wall. Now visibility of oncoming traffic is hindered. Stop sign needed.
- Arturo Martinez: Has an issue with street vendors who sell without permits. He purchased
 a food truck and obtained permits to sell legally, yet he has to deal with competition from
 food vendors who sell illegally. He feels he is being treated unfairly and is at a
 disadvantage. His fines and penalties for operating legally are less than those who operate
 illegally.
- Maricela Salgado: Has an issue with the illegal dumping in Mead Valley. Mead Valley is turning into a dumpsite. Sends pictures to county. Wants to create a petition. Trash is creating a health hazard for the community.
- Lincoln Cooper: Speaks for Concerned Family Events and Food service, Concerned Family health fair served 350 people. Starting a music class for youth. Only has 3 staff serving community and is looking for volunteers. His organization helped 50 people get jobs and off the streets.
- Pepe Del Rio: Community activist who cleans up after the community. Calls and picks up dead animals, watch out for kids on bikes with no lights, pleads to the community to clean up and do what you can for the community.
- Yolonda Williams: Has an issue with the county not cleaning up the right of ways they are
 responsible for. Has issues with the increase in illegal vending. Has an issue with the truck
 traffic on Old Elsinore Road. Has an issue with a property on the corner of Orange and
 Elsinore Rd.

- Mr. DeFries: Fox Street water tank has a 12" main installed, people looking for work should go to business's on Perris Blvd with help wanted signs. Take the RTA for transportation issues.

- Mr. Trevino: Unemployment in Riverside county has dropped to 3.8%, things are changing for the better.
- Veronica Valencia: For those who are going to speak in Spanish please request a translator in advance.

7.0 Report from Supervisor Kevin Jeffries' office

- 7.1 Thomas Ketcham, Legislative analyst to Supervisor Kevin Jeffries
 - West Coast Thunder event changed with not notice to the County Supervisors' Office
 - Sharon Bridges for Riverside County Cemetery explains the event is for charity, it benefits the cemetery, 5000 bike riders anticipated, should not last more than 1.5hrs, will end with a show and Color Guard at Storm Stadium.

- Environmental Health speaks on the street vending. The state is asking counties to be more flexible on food vending by mandate and the county is abiding. Enrique and Beatriz explain what can and cannot be done in both English and Spanish. * note, their appearance at the MAC meetings will be scheduled regularly if you wish to hear in more detail.
- Tom Ketcham: community cleanup will be on May 18th
- On Street vending issue, don't buy from illegal vendors and problem will fix itself.
- On road issue, if you live on a county road, call Tom and issues will be handled. If you live on a private road it is owner's responsibility unless the owners all dedicate the property to the county.
- On the issue of illegal dumping, call Tom if it is on the right of way, but private property is the responsibility of the owner no matter who dumped it.
- On the issue of Police, do not call Tom or the MAC board, call Sheriff directly. He is an elected official and needs to hear from his constituents.
- On the issue of truck traffic. It is inevitable that with growth comes traffic. District 1
 Supervisor Kevin Jeffries sits on the board of March JPA and has voted to not having
 more large development projects until the issue with traffic on the 215-60 corridor is
 reviewed and solutions proposed. Smaller projects are needed to keep residents local.
- On the issue of marijuana grows, It is a state mandate but grows are still illegal in the county and being eradicated as they are discovered.
