## SUPERVISOR KEVIN JEFFRIES FIRST DISTRICT Highgrove Community Update 1/25/2023

**Supervisory District Changes:** – As of January 1, 2023 Supervisor Kevin Jeffries’ Office took over the responsibilities of the Highgrove area. Our office will be responsible for County Land Use, Riverside County Transportation, Riverside County Code Enforcement, all other county agencies, and other constituent services in the Highgrove region. In addition to those county agencies, the Highgrove MAC meetings will be facilitated by Supervisor Jeffries’ office including MAC Board schedules and specifics of future meetings. **Supervisor Jeffries/ District 1 Brief Bio:** Supervisor Jeffries was first elected to serve District 1 in November 2012. Supervisor Jeffries has been a resident of Riverside County since 1971 (with family ties dating back to 1944). Kevin is a successful small business owner who has owned and operated his investment businesses in Riverside County for 30 years.

Due to the 2020 census, redistricting has now officially moved numerous County Supervisor boundaries. The unincorporated community of Highgrove and the City of Perris will join the entire City of Riverside for the New District 1. The communities of University City, Mead Valley, Good Hope and Meadowbrook stay in District One. The cities of Wildomar, and the unincorporated communities of La Cresta, Tenaja and DeLuz, remain in the old First District until January 2024 at which time it will switch to the revised 3rd District.
