4.1 Department of Animal services – Programs and Services, Director Erin Gettis and Lt. of Field Services Lesley Huennekens

- There was a presentation of extensive PowerPoint shown
- There are 4 Riverside County Animal Shelters
 - Western Riverside
 - San Jacinto
 - Coachella
 - Blythe
 - Plus, multiple additional city and area shelters in the greater Inland Empire,

-Animal Services has 17 city contracts, 4 are in San Bernardino County serving 1.69 million residents

-Rough numbers of animals in Riverside County, 11 thousand horses, 500k+/dogs, 36 thousand+ cats and 60% of County residents own pets

- Approximately 81,000 dogs have licenses

- County Shelters take in about 26,000 animals a year
- There is a shortage of Veterinarians in the County, and it is projected by 2030 there will be a shortage of 15,000 Veterinarians nationwide

- Prior to the pandemic Animal Services preformed 8900 Spay/neuter surgeries current level is 16,000

- Large number of people are giving up their pandemic puppies

- Lengthy discussion followed on a wide variety of Animal Services topics, please access Animal Services website listed above for additional information

4.2 Department of Air Quality Management District (AQMD) Air Quality Updates Deputy Executive Officer of Legislative, Public Affairs & Media, Derrick Alatorre

- http://www.aqmd.gov
- AQMD is a multi-jurisdictional agency and oversees over 27,000 facilities in all of Orange County and most of Riverside and San Bernardino Counties
- One group in the AQMD manages the system and issues permits within its jurisdictional area
- There is also an Enforcement Compliance division that inspects its permitted facilities and issues notices of violations
- AQMD has approximately 900 employees
- And a 10,000 square mile area of responsibility
- General review of the effectiveness of the Purple Air Sensors deployed in the Temescal Valley
- The Purple Air PM2.5 are very efficient in detecting PM2.5 particulate matter, but do not effectively measure and detect PM10.
- They are designed to detect odors
- Discussion was held regarding having an air monitoring station in the Temescal Valley due to the large number of mines in the area and the Landfill,
- Issues that would need to be addressed are having a secure location that would meet the requirements
- Costs of PM10 detectors are high and question was raised regarding possible an EPA Funding Grant
- Question was raised regarding the possibility of having toxic particulate matter study conducted.
