**4.1 CDBG Sterlon Sims, RIVCO EDA**, Have completed surveys for needs assessments, however was still accepting applications for 2015-2016 through

11/21/2014. For 2014-2015 fiscal year, 9.8 million was received: 1.7 million-homes, 7.4 million breakdown, 583,000 for emergency solutions. Funds were used to demolish the building in the park, sidewalks at Good Hope School, and community cleanups. Funds are used to help low-income individuals with code violations. Requests made to Parks for the Center, Parks would make an application to EDA *Question:* Diana Martin: re MARS program. *Answer:* under EDA. Listed on the Web Site under the 5 year Consolidated Plan.
