3.0 Public Safety Updates:

3.1 Riverside County Sheriff's Department: Deputy Thomas

- May 2013 & 2014 statistics: Crimes have gone up in the last two weeks. Assault w/deadly weapon, domestic violence, metal thefts, car thefts, and petty thefts have all gone up.
- Kids have been breaking into houses for adults. I would like a person to call 911 if they see anyone that is suspicious. Try to give a good description.
- Resident: *Question*-Do we have a neighborhood watch program? *Answer*-No. If one is started the Sheriffs Dept. can come to a meeting to help get it properly set up.
- ROMERO: *Comment*-Can you please inform the residents of the "No Trespassing" sign *Response*-If you have a "no trespassing" sign and an individual comes into your property you can do a citizen's arrest.
- Loud music: we try to get to them as fast as we can but we have to prioritize (i.e. handle robberies first).
- Parties: If guest list is over 150 people there has to be a permit, an ABC permit, let sheriffs dept. know and you have to hire a security guard

4.0 <u>New Business</u>:

4.1 Inland County Legal Services: Darrel Moore, Deputy Director

- We are a federally funded organization that provides free legal service for those that are qualified for the grants we receive.
- We have 5 offices, 22 attorneys, and 15 paralegals
- We help with housing issues, family law, consumer protection, public benefit issues
- Eligibility to obtain free services is determined by income, assets, and citizenship status (have to be U.S. citizen or permanent resident)
- Gerardo Avila, Resident: *Question*-What are the chances that you win against someone who is hired privately? *Answer*-We are probably the best with the limited resources that we have. My lawyers are specialized in the specific cases that we take. They are very good at what they do.
- Disclaimer: I can answer general questions but specific information shared here is not protected by client-attorney privileges.
- Resident: *Question*-Do you handle real estate cases? *Answer*-we do not turn down any eviction cases as long as you are eligible.
- Resident: *Question*-Do you make referrals on cases that you do not handle? *Answer*-Yes. We have a resource list of other organizations like ICLS.
