Kevin's Corner

Nearly \$22 Million Down The Drain? In what can only be described as the California Secretary Of State Charlie Brown football saga (Lucy pulling the football every time Charlie Brown attempts to kick it), our Registrar of Voters is once again being forced to replace our voting machines. In March 2000, the County of Riverside purchased 4,250 state-approved (certified) electronic voting machines for \$15 million. In November 2003, the State changed its mind and ordered that these voting machines be replaced by July 2006.

In January 2006, the County of Riverside purchased 3,700 new state-approved voting machines for an additional \$15 million (offset by some state grant funding). In November 2007, the State once again changed its mind and decertified the new electronic machines just purchased by our county, but generously allowed the county to use one machine (along with paper ballots) in each polling place until a new system was again approved by the State. We subsequently have spent almost a million dollars trying to prop up our old system while we wait for the next generation of voting machines to be approved by the Secretary of State.

Now, in February 2019, the Secretary of State has decertified our machines again, along with a majority of the counties in the state, ordering them to purchase new voting machines, and cease using our current paper ballots, before the 2020 elections. They promise to help pay for a portion of them, but the State has been less than reliable in doing so in the past, to put it charitably. Fortunately, we have already been looking at the problems with our existing machines, and this past January, Supervisor Washington and Supervisor Spiegel were appointed to work with our County Registrar of Voters to identify possible solutions and funding. I suspect my two fellow Supervisors will do everything they can to make sure the State of California does not pull a Lucy on us yet again.

Lobbying For Your Dollars? Roughly every two or three years the Board is requested to evaluate and fund lobbying efforts in Sacramento (\$210,000 for next fiscal year). The staff presentation indicated that our county is spending far fewer dollars than other counties on state lobbyists. Unfortunately, I suspect the report to the Board did NOT include lobbyists employed by a few stand-alone departments for such services as airports and flood control. My additional concern was a specific proposal to renew one contract with a firm that had NO reported success over the past two years on behalf of Riverside County. I was however told that the questionable firm does issue a very nice informative newsletter. So for \$60,000 a year we can at least continue to read about how badly Riverside County is being treated by our State government (see paragraph below).

Short Changed \$140 Million a Year and Growing? \$140 million is the estimate as to how much all Riverside County residents are short changed by the State of California EVERY year for countywide mental health services. Since 1991, state spending per person has increased \$15 in San Francisco while it has DECREASED by 59 cents in Riverside County. This disparity is caused by a discriminatory state population funding formula that essentially rewards (or at least protects) coastal counties at the expense of faster growing inland counties. Riverside County will never be able to provide the same level of public services when compared to the favored politically connected coastal counties so long as state bureaucrats continue to treat all of us as second-class citizens. Perhaps our expensive lobbyists will surprise us all and earn their pay with this ongoing challenge.




Non-Profit Spotlight RIVERSIDE COUNTY OFFICE OF EDUCATION FOUNDATION






