## **Kevin Jeffries Takes Office**

## **KEVIN'S CORNER**

On November 6<sup>th</sup> the voters of the First District gave me the green light to represent them as their next Riverside County First District Supervisor. On January 8<sup>th</sup>, I was honored to be officially sworn-in--and we have not slowed down since.

So what does a County Supervisor do? Well, Riverside County has 5 elected Supervisors, each representing almost half a million people. In some ways the County Board of Supervisors is like a city council, except the Supervisors are responsible for the entire county – not just a single city. While many cities have their own police and fire departments, the county (via your tax dollars) also provides funding for the County Sheriff's department, fire department, roads, flood control, county hospital, county jails, probation, county code enforcement, building & safety. mental health, environmental health, libraries, regional parks & trails, veteran services, waste management, animal services, and the list goes on.

Riverside County is the 5<sup>th</sup> largest county (out of 58 counties) in California. In fact the population served in Riverside County is bigger than 15 states and is approximately the size of New Jersey. In my office we have a full time staff of seven (and an intern from UCR) working out of the County Administrative Center in downtown Riverside (see article on staff

elsewhere in this newsletter). In a few months, I'm hoping to open an office in Lake Elsinore, to better serve the Southwest Riverside communities of Canyon Lake, Lake Elsinore, Wildomar, Temescal Canyon, Lakeland Village, El Cariso, Meadowbrook, Good Hope, La Cresta and DeLuz

Our office(s) will always strive to promptly return your calls for assistance, and to be open and accessible. We will work to keep our communities safe, encourage private sector job creation in Riverside County, protect our quality of life and make sure that you're hard earned tax dollars are spent wisely and effectively. Each month we plan to issue an email newsletter to keep you informed about your county government. 

## Supervisor Success Stories

Each month this column will highlight recent successes in Supervisor Jeffries' Office, whether it is assistance for a single citizen dealing with the county bureaucracy, a change in county policy to improve our community, or a promise kept by the Supervisor.

**BUREAUCRACY BUSTER:** After years of frustration attempting to navigate through the County permit process on her own, small business owner Linda Shaver recently contacted our office for assistance. Ieffries staff member Bob Magee and the Supervisor worked with the county bureaucracy (and their management), and with their help, finally received approval this month to build her new Hair Depot! Her current building at the corner of Grand Avenue and Adelfa Street in Lakeland Village will continue to serve her clients while she constructs the new 936 sq. ft. building on the same site. Linda plans to submit her building plans shortly and hopes to be in her new building soon.



### FREED OF UNFAIR FINES: A

Perris Valley resident contacted our office after being assessed \$7,000 in fines by Code Enforcement for violations that had occurred under a previous property owner. Even though Code Enforcement acknowledged that he had not created the problem, and was making progress towards mitigating the problem, they had refused to waive the fines. Jeffries staff member Tom Ketcham was able to work with Code Enforcement and the constituent to eliminate the fines resulting from the previous owner, which will help the new owner be able to afford to continue to improve his property and clean up the mess left by the previous owner.

PROMISE KEPT: Supervisor Jeffries has promised the residents of the 1st District that they would not be responsible for paying for his retirement, and before he even took office, he signed paperwork refusing to participate in the County Pension Program. He has also written a letter to initiate the process to refuse county contributions to the 401 A retirement accounts. It is his belief that being an elected supervisor is a public service, not a career, and that supervisors should be responsible for their own retirement funds.
