 - From Lake Mathews- Good Hope 1,000 calls were received in 2 months
 - 45 animals impounded, 31 injured animals, 22 aggressive dogs.
 - 6 bites investigated, 17 cruelty complaints, 67 dead animals.
 - Community involvement prevents bites.
